Important information

- 💧 **METER READING/IRRIGATION TURN OFF** The District will be reading water meters beginning **October 9, 2017**. *Homeowners are responsible for turning on/off their own irrigation and we urge you do it on or before that date.* The stop and drain valve should be turned one quarter (1/4) turn clockwise to shut the water off. It is the Homeowner's responsibility to insulate the water meter to keep it from freezing. Owners are also responsible for the protection of the outlet piping and valves including damage from freezing. Separate irrigation services need to be shut off at the curb stop (meter wrench required) and do not need to be insulated.
- 💧 **EMERGENCY CONTACT INFORMATION** There are emergencies such as mainline breaks, construction of new facilities and water quality issues that require the District to contact our customers in a timely manner. We serve over 8,000 customers – two-thirds of whom we do not have immediate contact information for - and it would be very difficult to contact all of them immediately without the use of telephone and media. Therefore, we urge you to register all cell phone numbers with a reverse 911 service. This is especially helpful if such an occasion should arise where water quality is concerned and your health may be at risk. One such company is www.safetyinformed.org. Others may be found on the internet. At the very least, we should have the best phone number for you and an email address. Please contact our office with this important information.
- 💧 **TEMPORARY CHLORINATION** The District will be temporarily chlorinating the water system north of the Spokane River for the period October 13, 2017 through November 17, 2017. We hope that by taking this proactive approach, our water samples will all be free of any coliform bacteria contamination introduced by improper sprinkler system blow-outs. Positive coliform samples affect the District's status with the Washington State Department of Health and could result in permanent chlorination. Please do your part and call the District if you see any improper sprinkler blow-outs. The District requires all customers with irrigation to have a proper backflow device.
- 💧 **IT IS EASY BEING GREEN** The District is making great strides in saving energy and resources. We urge you to do your part. If you receive a bill on a regular basis, please go to our website and sign up for paperless billing. It is easy and there is no charge to you. You can view and save your bills or look at a history of your bills and consumption. You will receive an email the day the bills are generated so it saves time. If you choose to utilize our bill pay options, there is a small service fee. You can also mail a check or stop by our office with cash or check.
- 💧 **DIRECTOR ELECTION** Director elections will be held for Division Nos. 3 and 4 in December of this year. A Petition of Nomination must be filed by 5:00 pm November 1, 2017. Each candidate must obtain a minimum of 10 signatures from landowners within said Division and candidate must be a landowner in the Division he/she is petitioning. Please refer to RCW 87 or our Bylaws posted on the District website for further information.
- 💧 **COLD WEATHER TIPS**
 - (1) **Insulate the meter box properly** (after domestic meters have been read). Insulation sealed in a plastic bag or a piece of Styrofoam placed over the top of the meter and tightly against the sides of the meter box are good methods of insulation. It is not necessary to wrap the meter or pipes.
 - (2) **Remove hoses from outside faucets** and be sure they are drained and shut off. Also, make sure your underground sprinkler system is properly drained.
 - (3) **In extremely cold weather,** a pencil size stream of water left running will help prevent your service line from freezing.
 - (4) **If you plan on leaving for the winter months** you may wish to winterize your home, draining all water.
 - (5) **Make sure your irrigation valve has been** shut off and your system drained.
- 💧 **IMPORTANT SPRINKLER SYSTEM BLOW-OUT INFORMATION** If a sprinkler system is blown out incorrectly, contaminated water may be forced back into the water system. Contamination could include decayed vegetation or other organic materials which may cause illness. Unsatisfactory water samples may also result from improper system blow outs. **Backflow assemblies are required by the State of Washington on all sprinkler systems.** Please make sure backflow assemblies are installed properly and the main shut off valve is closed prior to blowing out your system. A little care will prevent potential serious health risks. Your cooperation is appreciated.
- 💧 **WATER QUALITY** Consolidated Irrigation continually monitors the water supply to ensure its purity and quality. Over 80 substances (required by EPA and State Dept. of Health) are tested for. Listed below are ongoing programs that help protect and ensure our water quality. You can always find our Consumer Confidence Report on our website.

Programs for Protecting Water Quality

Wellhead Protection Program to protect the District’s groundwater resources.

Cross Connection Control Program to protect the District’s water from contamination.

Chemical and Bacteria Monitoring Program to ensure that the water is safe.

Reservoir Maintenance and Inspection Program to protect distribution system water quality.

Flushing of “Dead End” lines to prevent stagnant water and taste and odor problems.
